## Summary

Activities performed in this field of protection of animals against cruelty and their welfare in the Czech Republic have been carried out in line with Act No 246/1992 Coll., on the protection of animals against cruelty, as amended (Animal Welfare Act), last amended in 2009. Also applied were the relevant European Community (EC) regulations. The Bulletin presents the evaluation of these activities and information for the period from 1993 to 2010, with more thorough analysis of the situation prevailing in 2010. It includes results of the coordination activities performed by the Ministry of Agriculture and other state administration authorities as well as results of supervisory activities carried out by the Veterinary Administration inspectors. It contains information on the implementation of the AWA, including the activities of Animal Welfare Unit of the Animal Commodities Department of the MoA and activities of the Central Commission for Animal Welfare (CCAW). Also presented is a list of effective legislation and the methodology of supervisory and control activities. Elaborated and published are the summaries required by the EC, namely both with respect to the evaluation of conditions of activities involving farm animals and to the set methodology for the evaluation of the use of animals in experiments.

Throughout the period concerned, the supervision of the animal protection and animal welfare was performed by the Veterinary Administration bodies, namely a total of 207 500 inspections were carried out. In 2010, the inspectors of Regional Veterinary Administrations (RVA) conducted a total of 12 841 inspections. The number and type of planned inspections was determined based on the risk analysis in line with the "Multi-annual Plan of Inspections". In 2010, deficiencies were detected during 842 inspections and involved 373 762 animals. The number of proposals to initiate the administrative procedure pursuant to the Animal Welfare Act submitted to the municipal authorities of municipalities with extended powers slightly increased in 2010 to 442, compared to 426 proposals submitted in 2009. Nonetheless, an account has to be taken of also other penalties imposed. According to the data received from the Ministry of Justice, a total of 681 persons have been prosecuted and 350 persons have been convicted for cruelty to animals pursuant to the Penal Code since 1993. In 2010, a total of 19 persons were prosecuted, 15 persons were charged and 20 persons were convicted for the cruelty to animals; 15 persons were tried summarily.

The analysis of inspections performed in farm animal husbandry indicates that the largest share (92%) of inspected animals remains to be represented by poultry, though the inspections in poultry accounted only for 7 % of the total number of conducted inspections. The balance of inspection methodology is proven by the fact that with respect to the size of herds, 59 % of inspections had to be carried out at cattle farms, though the number of inspected animals in case of cattle represented only 1 %. Similar situation prevailed in inspections of pig, sheep and goat establishments. The presented charts show the distribution of inspections and compare the situation in the period from 1994 to 2010. Judging from the number of inspections of monitored activities, the charts indicate that in recent years the number of inspections slightly dropped in case of farm and companion animals. In 2010, a total of 8 790 inspections were conducted in farm animals. Deficiencies were detected during 419 inspections and involved 363 666 animals, which represented 4.2% of law violations. Higher percentage of recommended measures (in 2008: 12.4%; in 2009: 12.5%, in 2010: 11%) and law violations (in 2008: 8.9%; in 2009: 11.2%; in 2010: 10.2%) was reported in companion animals. In this category a total of 3 615 inspections were conducted. The total of 398 cases of detected deficiencies was addressed by many different ways. In the supervision of activities involving wild animals, there were 25 cases of deficiencies detected during 313 inspections. No deficiency was detected in the category of laboratory animals during 123 inspections. In 2010, a total of 366 007 live animals were used for experiments in the CR (compared to 380 128 animals in 2009), of which 69 779 laboratory mice, 35 485 laboratory rats, 6 538 rabbits, 3 259 guinea pigs, etc.; approximately 149 200 birds were banded.

The development of research activities and vocational training in the field of animal welfare was achieved primarily thanks to grants. Many results were presented at the University of Veterinary and Pharmaceutical Sciences in Brno on the occasion of the 17<sup>th</sup> Conference "Animal Protection and Welfare", attended also by foreign experts. Considered important can be the seminar called "Current Legal and Practical Aspects of Animal Handling" held by the Faculty of Law of the Charles University in Prague. Held again were the qualification courses for veterinary surgeons focused on the performance of supervision of animal protection (Section 26 of the AWA) and courses focused on the management of experiments on animals (Section 17 para 1 of Animal Welfare Act). At 6 training centres courses took place for transporters of animals covering the requirements laid down in Council Regulation (EC) No 1/2005 on the protection of animals during transport and related operations. Vocational training of persons for the acquisition of qualification for the capture of stray animals and care of them was under way. In line with the implementation of Council Directive 2007/43/EC, a training was provided to 374 persons responsible for the care of chickens kept for meat production. Moreover, a course was held in which the trainees acquired the competence of persons responsible for the care of handicapped animals. The topics of animal welfare and provision of minimum standards were on the agenda of regional courses and seminars for breeders. A number of events dedicated to animal welfare took place also on other occasions. The non-governmental organisation Foundation for the Protection of Animals evaluated the grant procedure for 2010 and announced more grants related to animal welfare. This foundation also organised an event called "Fill the bowls" in support of animal shelters for animals in need. Already the 3<sup>rd</sup> seminar on animal protection held by the Society for Animals of the Czech Union for Nature Conservation for members of interest associations met with success. The organisation of activists organised protest events against the battery cages for keeping laying hens and Christmas sale and slaughtering of fish.

The presented data was obtained from the Integrated Agricultural Register of the Ministry of Agriculture, the Czech Statistical Office database, EU TRACES information system and the welfare module of the SVA CR Information System. The obtained data was used by the State Agricultural Intervention Fund (SAIF) as an indirect economic tool of animal protection in connection with granting aid.

## E 1. INTRODUCTION

The presented bulletin, just like every year, contains information on the protection of animals and their welfare in the Czech Republic (CR) in the period from 1993 to 2010, with focus on the analysis of activities conducted in 2010. Activities performed in this field in the referred to period were carried out in line with Act No 246/1992 Coll., on the protection of animals against cruelty, as amended (Animal Welfare Act), last amended in 2009. The information clearly shows that newly applied were the requirements laid down in the amended or newly adopted decrees implementing the referred to Act as well as directly applicable European Community (EC) legislation. The requirements laid down in the transposed Council Directive 2007/43/EC laying down the minimum rules for the protection of chickens kept for meat production were implemented. Pursuant to the amendment to the Animal Welfare Act, the obligations of breeders of chickens kept for meat production were imposed starting with 1 January, 2010. Decree No 114/2010 Coll., on the protection of handicapped animals in breeding and Decree No 128/2010 Coll., on competence for identification of dogs by tattooing were adopted. Significant changes in animal protection, namely in the field of sanctions imposed in case of cruelty to animals, were introduced by the new Penal Code – Act No 40/2009 Coll. which became effective on 1 January 2010.

Since the beginning of the monitored period the supreme animal protection authority in the CR has been the Ministry of Agriculture (MoA), responsible for the performance of state administration in this field. As of 1 January 2009 the Animal Welfare Unit was newly set up within the Animal Commodities Department of the MoA. Following this restructuring, the Central Commission for Animal Welfare (CCAW), composed of representatives of the competent state authorities and non-governmental organisations, has become an advisory body to the Minister of Agriculture. Thus, the CCAW is no more a state administration authority and a competent body in the field of protection of animals against cruelty. MVDr. Pavel Bohatec, a member of the Parliament of the CR, was appointed the new chairperson of the CCAW and in 2010 he was replaced by Ing. Radim Fiala, also a member of the Parliament of the CR.

The bulletin presents the current methodological procedures to be applied by supervisory bodies of the State Veterinary Administration of the CR (SVA CR) in their activities, accompanied by evaluations of and comments on these activities as well as presentation of data in tables, charts and maps. An integral part of the bulletin is the data required by the EC bodies and the Council of Europe (CoE). It provides information on activities performed by the Animal Welfare Unit of the MoA, including information on the use of experimental animals. Also described are the activities conducted by the CCAW. Traditionally, the bulletin presents data obtained from the Ministry of Justice (MoJ CR) concerning penal procedures in this field.

In the framework of grants, further development of research activities and vocational training in the field of animal welfare was under way. A major step ahead is the presence of these matters in social sciences, as proven e.g. by the seminar called “Current Legal and Practical Aspects of Animal Handling” held by the Faculty of Law of the Charles University in Prague. The 17<sup>th</sup> conference “Animal Protection and Welfare” was held at the University of Veterinary and Pharmaceutical Sciences in Brno (UPVS), which was attended also by foreign experts. Also organised was already the 25<sup>th</sup> specialised seminar “Topical Issues of Bioclimatology of Animals 2010“, held in Brno by the Czech Society of Bioclimatology. Traditionally, the qualification courses for veterinary surgeons focused on the performance of supervision of animal protection (Section 26 of the AWA) and courses focused on the management of the experiments on animals (Section 17 para 1 of Animal Welfare Act) were held. At 6 training centres courses took place for transporters of animals covering the requirements laid down in Council Regulation (EC) No 1/2005 on the protection of animals during transport and related operations. Vocational training of persons for the acquisition of qualification for the capture of stray animals and care of them was under way. In line with the implementation of Council Directive 2007/43/EC, a training was provided to 374 persons responsible for the care of chickens kept for meat production. Moreover, a course was held in which the trainees acquired the competence of persons responsible for the care of handicapped animals (Section 14b para 3 of the AWA). Worth mentioning is also the education and outreach activities carried out in cooperation with breeders' associations and interest organisations. The topics of animal welfare and ensurance of minimum standards were on the agenda of regional courses and seminars for breeders. A number of events dedicated to animal welfare took place also on other occasions. The non-governmental organisation Foundation for the Protection of Animals evaluated the grant procedure for 2010 and announced more grants related to the protection of companion animals. This foundation also organised an event called “Fill the bowls” in support of animal shelters for animals in need. Already the 3<sup>rd</sup> seminar on animal protection held by the Society for Animals of the Czech Union for Nature Conservation for members of interest associations met with success. The organisation of activists held protest events against the battery cages for keeping laying hens and Christmas sale and slaughtering of fish.

The presented information was obtained from the Integrated Agricultural Register of the MoA, the Czech Statistical Office, EU TRACES system and the welfare module of the SVA CR information system. This module

was upgraded in order to meet the requirements of the new legislation as well as inspection practice of RVA inspectors. The obtained data was used by the State Agricultural Intervention Fund (SAIF) as an indirect economic tool of animal protection in connection with granting aid.

## **E 2. BRIEF OVERVIEW OF LEGISLATION OF THE CR RELATED TO ANIMAL PROTECTION**

### **(status as of 1 January 2011)**

The animal protection is currently laid down to a higher or lower level of detail in a number of legislation. This body of legislation is so extensive that it is useful to divide it into two categories. It is therefore possible and generally accepted in the field of animal protection to divide it into the so called direct and indirect protection of animals against cruelty. Direct protection of animals against cruelty covers the protection of animals as stipulated by legislation defining, prohibiting and penalising activities considered to be the cruelty to animals. Indirect protection of animals against cruelty covers the protection of animals as stipulated by legislation laying down the handling of animals and protection of their welfare and health. That means the legislation the main aim of which is not the protection of animals against cruelty, which nevertheless through its provisions contribute to the protection of animals.

### **E 2.1. Overview of legislation in the field of protection of animals against cruelty**

- Decree No 448/2009 Coll., laying down hygienic requirements for cosmetic products, as amended.

- European Convention for the Protection of Animals for Slaughter, No 114/2003 Coll. of International Treaties,
- European Convention for the Protection of Vertebrate Animals Used for Experimental and Other Scientific Purposes, No 116/2003 Coll. of International Treaties,
- The Protocol of amendment to the European Convention for the Protection of Vertebrate Animals Used for Experimental and Other Scientific Purposes, No 118/2006 Coll. of International Treaties.

The above mentioned conventions constitute the basis for animal protection legislation also in the European Communities and their general principles are also enshrined in the Czech legislation.

## E 2.2. Changes in legislation governing the protection of animals against cruelty in 2010

At the end of 2008 and at the beginning of 2009 considerable changes were made in the Czech legislation governing the protection of animals against cruelty. A major amendment to Act No 246/1992 Coll., on the protection of animals against cruelty, as amended, was adopted. **Act No 312/2008 Coll., amending Act No 246/1992 Coll., on the protection of animals against cruelty, as amended, Act No 634/2004 Coll., on administrative fees, as amended, and Act No 114/1992 Coll., on nature and landscape protection, as amended** took effect on 1 October 2008. In connection with this amendment another decree was adopted in 2010.

**Decree No 114/2010 Coll., on the protection of handicapped animals in breeding** stipulates the requirements for the breeding of handicapped animals, equipment and the minimum space requirements for handicapped animals, the scope of technical knowledge necessary for the acquisition of a certificate of professional competence of persons responsible for the care of handicapped animals, the content of the specialised training course for the acquisition of this professional competence, requirements for the training centre, composition of the board of examiners, course of the examination, conditions for and method of issuing the certificate and a specimen of the certificate.

Decree No 114/2010 Coll., on the protection of handicapped animals in breeding became effective on 7 May 2010. The space requirements and equipment of spaces for selected species of handicapped animals are laid down in Annex No 1 to the Decree that will take effect on 1 April 2013. The reason is to give sufficient time to the existing entities that currently fail to meet some of the set requirements to adjust to the new legislation and to spread the potentially incurred expenditure for building alterations over several years.

On 4 September 2009, **the Act No 291/2009 Coll., amending the Act No 252/1997 Coll., on agriculture, as amended, and other related laws** was promulgated in the Collection of Laws in Chapter No 90. **As a part of this Act also the amendment to Act for the protection of animals against cruelty was discussed**, see part three of the amendment. The Act became effective on the first day of the first calendar month following the day of its promulgation, i.e. on 1 October 2009. Some provisions of the Act for the protection of animals against cruelty, governing the protection of chickens kept for meat production, took effect only on 1 January 2010 (obligations of breeders) or on 30 June 2010 (penalties imposed upon breeders of chickens kept for meat production for not meeting these obligations). Based on this amendment, two decrees were adopted.

On 23 December 2009 the **Decree No 464/2009 Coll. amending Decree No 208/2004 Coll., on minimum standards for the protection of farm animals, as amended by Decree No 425/2005 Coll.** was promulgated in the Collection of Laws. This Decree, except for certain provisions, became effective on 1 January 2010. The main reasons behind the amendment to the Decree was the transposition of Council Directive 2007/43/EC of 28 June 2007 laying down minimum rules for the protection of chickens kept for meat production, replacement of some provisions of the repealed Decree No 191/2002 Coll., on technical requirements for agricultural buildings, and increased level of protection of farm animals. Some provisions were made more specific order to achieve full compliance with the directives in the field of protection of animals against cruelty, e.g. provisions of Section 3 laying down the minimum standards for the protection of pigs. Provisions of Section 6

newly define the basic conditions for keeping ducks, geese and turkey hens. Conditions and requirements for their keeping shall meet the biological requirements of kept species, which in these species are so specific that were laid down in line with the adopted Recommendations of the Standing Committee of the European Convention for the protection of animals kept for farming purposes. Minor changes have also been made in the field of protection of cattle, sheep and goats, laying hens and horses. These modifications will not increase the burden put on animal keepers.

**Decree No 128/2010 Coll., on competence for identification of dogs by tattooing** is an implementing regulation to Section 7 para 5 of the Act on the protection of animals against cruelty. In accordance with this provision, the identification of dogs by tattooing can be performed only by a veterinarian or a person who has completed a training on animal tattooing and has been granted a certificate of competence for this activity. The training shall be held by a higher education institution offering a veterinary study programme, which shall issue a certificate to participants who completed this training, authorising them to perform tattooing on animals, and keep a list of these persons. The implementing regulation shall define the content, scope and organisation of the training on animal tattooing, methods and way of verification of acquired knowledge, issuance of certificates and keeping a list of graduates from these courses. This authorisation was added in the course of discussions on the amendment to the Act on the protection of animals against cruelty in the Chamber of Deputies of the Parliament of the CR by a private member's bill. The authorisation was provided for by Act No 291/2009 Coll. to apply only to dogs, not to all the animals. This decree took effect on 21 May 2010.

The person professionally competent for the identification of dogs by tattooing in accordance with Section 7 para 5 of the Act on the protection of animals against cruelty cannot perform the identification of animals in accordance with the generally binding decrees in the field of protection of animals against cruelty, namely because such a person is not considered to be professionally competent in accordance with the Veterinary Act.

Major changes in the field of protection of animals against cruelty have been introduced by the new Penal Code - **Act No 40/2009 Coll., Penal Code** which took effect on 1 January 2010. The new Penal Code introduces changes in the field of punishment for the cruelty to animals. During the comment procedure the Ministry of Agriculture took an active part in the wording of new provisions of the Penal Code regarding the tightening of punishment for cruelty to animals or torturing animals to death. It concerns the extension of the terms of imprisonment and the broader portfolio of cases punishable as an offense of cruelty to animals. The offense of "cruelty to animals" is defined in Section 302 of the Penal Code. A new offense of "animal neglect caused by negligence" - Section 303 of the Penal Code has been introduced. Due to the adoption of this new legislation, starting with 1 January 2010 certain acts, which have so far been dealt with by the municipal authorities of municipalities with extended powers as infractions pursuant to the Act on the protection of animals against cruelty, will be heard as offences by law enforcement bodies.

At the end of 2010 the works commenced on another **amendment to Act No 246/1992 Coll., on the protection of animals against cruelty, as amended**. This amendment was brought about by the necessity to incorporate Council Regulation (EC) No 1099/2009 of 24 September 2009 on the protection of animals at the time of killing and to transpose Directive 2010/63/EU of the European Parliament and of the Council of 22 September 2010 on the protection of animals used for scientific purposes. The amendment will most likely become effective on 1 January 2013, i.e. the date when the Regulation shall be incorporated in and the Directive shall be transposed to the Czech national body of law. The comments procedure on this proposal has not yet been in place since at the end of 2010 and at the beginning of 2011 the amendment was still under preparation.

**Council Regulation (EC) No 1099/2009 of 24 September 2009 on the protection of animals at the time of killing** shall apply from 1 January 2013. This regulation lays down rules for the killing of animals bred or kept for the production of food, wool, skin, fur or other products as well as the killing of animals for the purpose of depopulation and for related operations.

**Directive 2010/63/EU of the European Parliament and of the Council of 22 September 2010 on the protection of animals used for scientific purposes** imposes upon the Member States to adopt and publish, by 10 November 2012, the laws, regulations and administrative provisions necessary to comply with this Directive. This legislation shall be applied from 1 January 2013. This directive establishes measures for the protection of animals used for scientific or educational purposes.

### **E 3. ANIMAL PROTECTION PROGRAMME**

Veterinary care pursuant to Section 2 letter f) of Act No 166/1999 Coll., on veterinary care and amending certain related laws (Veterinary Act), as amended (hereinafter referred to as the "Veterinary Act"), comprises the

supervision of compliance with conditions and requirements set out by the referred to Act and special legislation, apart from others also by Act No 246/1992 Coll., on the protection of animals against cruelty, as amended, and/or directly applicable EC legislation (e.g. Council Regulation (EC) No 1/2005 of 22 December 2004 on the protection of animals during transport and related operations and amending Directives 64/432/EEC and 93/119/EC and Regulation (EC) No 1255/97 (hereinafter referred to as "CR (EC) 1/2005")), especially Regulation of the European Parliament and of the Council (EC) No 882/2004 on official controls performed to ensure the verification of compliance with feed and food law, animal health and animal welfare rules. For the sake of more rational use of workforce and resources the professional activity in the field of care for animal welfare and protection of animals against cruelty is, where possible, conducted together with the performance of other veterinary care activities. The methodology also reflects the current requirements and recommendations of DG(SANCO) missions. In order to achieve a uniform procedure of veterinary administration authorities in the field of protection of animals against cruelty and animal welfare, the Methodological Guidelines "Animal Protection Programme" (hereinafter referred to as the "AP Programme") was published. The following is included in the amendment of 26 April 2010:

### Organisational structure

1. Professional activity in the field of animal welfare and protection of animals against cruelty, particularly the methodological guidance of supervision and its performance in selected cases, regular evaluation of activities and submission of measures and professional proposals is conducted by the Department of Animal Health and Welfare – Welfare Division of the State Veterinary Administration of the CR (hereinafter referred to as the "SVA").

2. The performance of supervision of the observation of duties imposed upon breeders and other natural and legal persons pursuant to the Veterinary Act and the Animal Welfare Act and directly applicable EC legislation is entrusted to the competent Regional Veterinary Administrations and the Municipal Veterinary Administration in Prague (hereinafter referred to as the "RVA") which shall in this respect

- a) Authorise the use of other methods for euthanasia of animals pursuant to section 5h para 4 of the Animal Welfare Act, authorise derogations pursuant to Section 5 para 4 of the Animal Welfare Act,
- b) Issue, modify or withdraw the decision on authorisation to breed animal species requiring special care, namely the individual animals and groups of animals pursuant to Section 13 para 5 of the Animal Welfare Act,
- c) Receive notification as referred to in section 13a para 1 of the Animal Welfare Act and file a petition to the competent Trade License Office pursuant to section 13a para 2 of the Animal Welfare Act,
- d) Draw up expert opinions and issue certificates of the approval of a means of transport by road or a livestock vessel, suspend and withdraw these certificates,
- e) Issue an authorisation for transporters and an authorisation for transporters for long journeys,
- f) Notify the Ministry of any violation of directly applicable Community legislation regulating the protection of animals during transport and related activities by a driver or attendant who is the holder of a certificate,
- g) Carry out checks and other measures related to journey log,
- h) Make decisions on granting, suspending or revoking the approval issued for the control post,
- i) Determine veterinary conditions for the conduct of experiments on animals pursuant to Section 4 para 3 of the Veterinary Act,
- j) Impose corrective measures upon keepers and other natural and legal persons, namely in the form of a decision in accordance with provisions of Section 143 of Act No 500/2004 Coll., rules of administrative procedure, or in the form of a decision in accordance with provisions of Section 150 para 5 of the rules of administrative procedure, or in the form of a decision on a binding instruction [Section 52 para 1 letter b) of the Veterinary Act] pursuant to Part II of the rules of administrative procedure, and subsequently control their observation,
- k) File motions with the municipal authorities of municipalities with extended powers to initiate hearings of administrative delicts with respect to the violation of obligations imposed upon keepers and other natural or legal persons by the Animal Welfare Act; together with the filing or upon request raised by the municipal authority of the municipality with extended powers elaborate an expert opinion of the Veterinary Administration Authorities pursuant to Section 24a para 5 of the Animal Welfare Act, which is binding in the procedure on an infraction or an administrative delict, they also make sure that the municipal authority of the municipality with extended powers considered the filed motion and notified the RVA pursuant to Section 24a para 4 of the Animal Welfare Act,

- l) Inspect the conditions of animal protection for the organisation of a public performance or animal gathering, check compliance with conditions as laid down in Section 8 of the Animal Welfare Act,
- m) Pursuant to Section 28a (special measures) of the Animal Welfare Act submit proposals to the municipalities with extended powers for administrative decisions providing for a placement of animals in foster care, reduction of the number of kept animals and suspension of activities,
- n) Issue binding opinions pursuant to Section 56 of the Veterinary Act for buildings in which the animals will be kept (Decree No 208/2004 Coll.),
- o) Issue, amend and withdraw authorisation for natural and legal persons to conduct sanitary activities (capture of stray animals) in accordance with Section 39 para 2 of the Veterinary Act,
- p) Pursuant to Section 7 para 1 of Act No 449/2001 Coll., on game management, as amended, express their opinion on keeping game in captivity,
- q) In accordance with guidelines of the SVA CR process and provide the required information related to the state aid policy of the MoA of the CR,
- r) Issue opinions on territorial plans and binding opinions in the course of planning permission procedure with respect to veterinary care pursuant to Section 49 of the Veterinary Act,
- s) Issue opinions on establishing rescue stations for handicapped animals pursuant to Section 5 para 8 of Act No 114/1992 Coll., on nature and landscape protection, as amended,
- t) Elaborate opinions for licensing procedures pursuant to Section 5 para 1 of Act No 162/2003 Coll., laying down conditions for operating zoological gardens, as amended,
- u) Issue and withdraw authorisation for breeding chickens kept for meat production with higher stocking density pursuant to Section 12 para 4 of the Animal Welfare Act.

3. The qualification prerequisite for the authorization to perform the referred to supervisory and professional activities is the compliance with conditions of Section 26 of the Animal Welfare Act evidenced by a certificate. It is assumed that for the performance of supervisory activities the animal welfare inspector is equipped with personal protection equipment and relevant measuring devices (for measuring the length, temperature, etc.) and aids necessary for the performance of supervision (flashlight, aids for restraining animals, inclinometer, etc.).

RVA in line with its organisational structure shall:

- Designate an officer – Chief Inspector of the RVA for animal welfare and entrust him with the management and control of professional activities in this field,
- Authorise the RVA inspectors – veterinary surgeons to perform the supervision of animal welfare within the respective technical units of their workplace (e.g. veterinary hygiene centres - VHC, slaughterhouses, assembly centres) or within their defined area of responsibility (usually the territory of a district).

#### **Activities of the RVA Chief Inspector for animal welfare**

The Chief Inspector of the RVA for animal welfare is responsible for the management of technical aspects of animal welfare and for the supervision of animal protection at the level of the RVA. He manages the technical activities of inspectors – RVA veterinary surgeons for animal welfare, assigns them specific tasks in line with the MG. As laid down in the MG, he cooperates with chief inspectors or heads of RVA departments, or RVA inspectors, coordinates activities concerning animal welfare and regularly updates the RVA management, or the SVA, on his activities.

He develops a plan of inspections carried out in the field of animal welfare. He keeps and archives the technical documents associated with safeguarding animal protection and welfare. He is responsible for record keeping and checking of data on inspections of the “AP Programme” in the SVA IS welfare module. Monthly, on a regular basis, or whenever necessary and in line with possibilities of the software of the SVA IS data storage, he evaluates the results obtained in the respective administrative region.

Within the scope of RVA responsibilities, he shall manage, ensure and control the supervision of animal welfare and, if appropriate, also perform the supervision himself directly at the keeper. In his activities he shall ensure:

- a) supervision of welfare of farm animals in compliance with the elaborated plan,

- b) performance of regular – annual comprehensive inspections of animal protection and welfare at the time of slaughter at slaughterhouses and safeguards regular operation checks on animals at the time of slaughter at slaughterhouses and during seasonal sale of live fish,
- c) supervision of animal welfare in companion animal establishments, including establishments of dangerous animal species / animal species requiring special care, inspections in pet shops, protection of animals in horse riding and carriage driving activities, inspections of animal shelters including inspections of care of stray and abandoned animals performed by municipalities, population regulation etc.,
- d) supervision of welfare of wild animals, animals in zoological gardens, circuses and similar establishments,
- e) supervision of welfare of experimental animals,
- f) in case of deficiencies identified by other RVA professional staff or upon the notification of other persons, their immediate investigation and consideration,
- g) cooperation with animal protection authorities in the respective administrative area of the region and breeders, professional (Chamber of Veterinary Surgeons of the CR) and animal protection organisations,
- h) education and awareness enhancement activities in this field.

Following the inspection and verifications of facts:

- Drafts proposals to authorise the use of other methods for euthanasia of animals pursuant to Section 5h para 4 of AWA,
- Drafts proposals for issuance, change or withdrawal of the authorisation of breeding an animal species requiring special care, namely individuals or groups, pursuant to Section 13 para 5 of AWA,
- Receives notifications pursuant to Section 13a para 1 of AWA, keeps register of these entities (in line with the prescribed system, he sees to the assignment of the veterinary registration number) or drafts proposals for a petition to be filed with the competent Trade License Office pursuant to Section 13a para 2 of AWA,
- Drafts proposals for expert opinions for the purpose of granting the authorisation to an animal transporter, or the approval of the road vehicles for long-term journeys, keeps the respective documentation, submits proposals for revocation of the respective authorisations,
- Drafts proposals for the setting out of veterinary conditions pursuant to Section 4 para 3 of Veterinary Act for the execution of administrative procedures on granting the accreditation to a person operating a user establishment, issuance of a certificate for a person operating a breeding and supplying establishment, setting out of veterinary conditions in an experimental project (EP) pursuant to Section 11 of Decree No 207/2004 Coll., on the protection, breeding and use of experimental animals (or EP Point No 21) for the conduct of experiments on animals,
- Based on a control finding of RVA inspectors for animal welfare, drafts proposals for the imposition of binding instructions (Section 52 para 1 letter b) of Veterinary Act) in line with Part two of the Rules of Administrative Procedures upon breeders and other natural and legal persons,
- Based on a control finding, drafts proposals to be submitted to the municipal authorities of municipalities with extended powers in order to initiate hearings of infractions and administrative delicts with respect to the violation of obligations imposed upon animal breeders and other natural or legal persons by AWA,
- Based on a control finding, submits proposals to be submitted to the municipalities pursuant to Section 28a (Special Measures) of AWA in order to provide foster care of abused animals, decrease in the number of animals and suspension of activities,
- Submits proposals for the issuance, change and withdrawal of the authorisation to perform veterinary sanitation activities (capture of stray animals) pursuant to Section 39 para 2 of Veterinary Act to natural and legal persons,
- Presents opinions on spatial development plans and binding opinions in zoning procedure pursuant to Section 49 of Veterinary Act with respect to veterinary care,
- Conducts controls with regard to applications for the permission of a public performance of animals and confirms the fulfilment of requirements pursuant to Section 8 para 3 letter b) of AWA,

- Drafts proposals for an opinion pursuant to Section 7 para 1 of Act No 449/2001 Coll., on game management, as amended, concerning the breeding of game kept in captivity and pursuant to Section 7 para 1 of this Act concerning the conditions for temporary keeping of red fox in captivity for the purpose of training of hunting dogs,
- Drafts proposals for information, opinions etc required in line with the current needs of the RVA,
- Once the copies of relevant documents (including the copies of breeders' applications, or protocols on control findings) are approved, he collects and archives them in the prescribed manner,
- Based on a conducted inspection, drafts proposals for opinions on the occasion of establishment of rescue stations for handicapped animals pursuant to Section 5 para 8 of Act No 114/1992 Coll., on nature and landscape protection, as amended,
- Based on a conducted inspection drafts proposals for opinions with respect to licensing procedure pursuant to Section 5 para 1 of Act No 162/2003 Coll., laying down conditions for operating zoological gardens, as amended.

In terms of methodology in his activities he follows the instructions of the Welfare Division of the SVA CR.

### **Activities of RVA inspectors in animal welfare related activities**

1. RVA inspectors – official veterinary surgeons in the field of animal welfare protection, to the extent laid out in the assignment and instructions of the Chief Inspector of the RVA for animal welfare, shall perform the supervision of animal protection and welfare at their workplace (e.g. assembly centre, slaughterhouse) or within their defined territorial responsibility. They keep technical documents relevant for the ensurance of animal protection and welfare within their area of responsibility. They ensure record keeping, checks and archiving of inspections of the “AP programme” in the SVA IS welfare module database. They evaluate the results of the “AP Programme” obtained in the respective area under their territorial responsibility. In keeping with the guidelines they provide written or other topical information on their activities to the Chief RVA inspector for animal welfare, particularly in case of inspection findings of violation of animal protection legislation where they are involved in the preparation of supporting documents for further procedure.

In their professional and supervisory activities related to the protection of animals against cruelty and animal welfare within their territorial responsibility they focus especially on:

- a) comprehensive and follow-up inspections of the protection and welfare of farm animals in breeding,
- b) inspections of protection and welfare of animals during their movements,
- c) inspection of protection and welfare of animals at public performances,
- d) inspection of transport conditions, including “Register for road vehicle used for the transport of animals”, or “Journey Log” submitted prior to the transport of animals, during the inspection of the set control posts and after the end of the journey; pursuant to Council Regulation (EC) 1/2005 these documents shall be stamped by them in the prescribed manner,
- e) inspection of animal protection and welfare during veterinary activities,
- f) inspection of protection of companion (pet) animals, especially animals in shelters, in trade in companion animals, protection of animals in horse riding and carriage driving activities, etc.,
- g) inspection of animal species requiring special care establishments prior to the issuance of certificate and during the period of its validity,
- h) inspection of protection of wild animals and animals in training, particularly in circuses and similar establishments,
- i) addressing the notifications and complaints related to animal protection and welfare,
- j) development of background materials in the field of animal welfare concerning the territory within their responsibility for the RVA Chief Inspector for animal welfare, to be used as supporting information for the future decision making,
- k) cooperation with breeders and animal protection interest organisations,
- l) education and awareness enhancement activities in this field,
- m) are involved in the preparation of binding opinions pursuant to Section 56 of the Veterinary Act and in the issuance of binding opinions pursuant to Section 49 of the Veterinary Act for territorial (zoning) procedure with respect to the veterinary care,



- n) handing over of the by them issued decisions on corrective measures imposed upon keepers and other natural and legal persons in accordance with Section 143 or Section 150 para 5 of the Rules of Administrative Procedure.
2. RVA inspectors – veterinary surgeons in the field of veterinary hygiene ensure specific professional and supervisory activities in the framework of protection of animals against cruelty and animal welfare by:
- regular (“daily”) checks on animal protection and welfare during the transport of animal consignments to slaughterhouses,
  - regular (“daily”) checks on animal protection and welfare at the time of slaughter at slaughterhouses,
  - regular (at least once every quarter) evaluation of findings detected in the inspections of meat and organs,
  - checks on ritual slaughters – at every slaughter, no more than 10 times a year,
  - random checks on the seasonal sale of live fish - 5 % at least,
  - at least quarterly inspection focused on the records held by the operator on the arrivals and unloading of animal consignments, checks on the slaughtering devices and equipment used, etc.

The data is recorded in accordance with principles as defined in the user’s manual entitled Methodological support of the SVA CR Department for information and communication technologies for work with the client of the Information system of the SVA CR – Explanation of control points in record keeping of welfare inspections in RVA IS Client (hereinafter referred to as the “DICT manual”).

3. The above presented division of the specific professional and supervisory activities in the framework of protection of animals against cruelty and animal welfare within the RVA does not exclude the substitutability of inspectors and performance of other activities than those defined by this MG. It is recommended, though, to observe the principles of the referred to system because of links between the supervisory activities in the protection of animals and core professional activities as well as other vocational training and provision of organisational and professional information. It is also possible that based on concrete conditions also another RVA officer may become involved in the performance of supervision provided he satisfies the qualification requirements (see Article 1 para 2 of this MG).

### **Inspection plan and frequency of inspections**

- In the conduct of the scope of supervisory activities the differences between the activities in individual regions shall be respected, such as different intensity and level of agricultural production and other professional specifics of the administrative region (e.g. predominance of supervisory activities in companion animals in large towns and cities). The professional scope of inspections conducted reflects the requirements laid down in the legislation in force and the entities to be inspected are selected based on the risk analysis of the SVA CR and RVA for the given year.
- The determination of frequency of inspections and planning of activities follow the methodology of the Multi-annual National Plan of Inspections of the CR for the given year.

### **Keeping and archiving documentation in the field of care animal welfare**

Chief Inspector – head of the RVA Welfare Division and inspectors of this division in line with the defined territorial competences, except for documents in PC database, keep and in compliance with the prescribed requirements archive the relevant documents at their workplace.

### **Supervision, data processing and evaluation of results**

- During inspections the competent inspector – veterinary surgeon of the RVA authorised to conduct supervision in the field of animal welfare always completes the “Protocol on control findings – welfare”, the data of which are further processed and entered into the SVA IS welfare module database in line with the principles of the DICT user’s manual.
- Inspectors authorised to conduct the supervision of assembly centres conduct inspections of animal welfare in assembly centres and enter the data pursuant to the principles as defined in the DICT user’s manual in the SVA IS welfare module database. In case of a violation of the Animal Welfare Act, they produce a “Protocol on control findings – welfare” and immediately inform the Chief RVA inspector for animal welfare.

3. Inspectors – veterinary surgeons in the field of veterinary hygiene – in the supervision of animal welfare carry out daily checks of animal welfare at slaughterhouses and enter the data in line with the DICT manual in the SVA IS welfare module database. They also keep records of carried out regular checks focused on the records kept by the operator of arrivals and unloading of animal consignments, checks of used slaughtering devices and equipment, etc. In case of a violation of the Animal Welfare Act, they produce a "Protocol on control findings – welfare" and immediately inform the Chief RVA inspector for animal welfare who enters the data in the SVA IS welfare module database.
4. The inspection findings of seasonal sale of live fish are recorded in the "Protocol on control findings - welfare", the data from which is entered in line with the principles of the DICT user's manual in the relevant SVA IS welfare module database.
5. The SVA CR IC develop national overviews of activities in the field of protection of animals against cruelty and animal welfare:
  - a) monthly, no later than on 15<sup>th</sup> of the following month, and published them in the requested scope on the SVA website,
  - b) annually,
  - c) following the SVA CR requirements.
6. Annual results of the "AP Programme" are submitted by the SVA CR to the Ministry of Agriculture.
7. In accordance with requirements of international treaties and conventions (in bilingual version), the "AP Programme" results are submitted:
  - through the intermediary of the Standing Committee of the European Convention for the protection of animals kept for farming purposes to the Secretary General of the Council of Europe,
  - to the Standing Committee on the Food Chain and Animal Health of the EC no later than on 30 April of the following year.

### Professional inspection

1. **Professional inspection of compliance with the MG by individual RVA inspectors** with the defined territorial responsibility and by inspectors-veterinary surgeons in the field of veterinary hygiene, during supervision of animal welfare, by inspectors at assembly centres and inspectors at other prescribed workplaces is conducted by the RVA Chief inspector for animal welfare, or another RVA inspector designated by the RVA Director at least once every six months. In case of detected deficiencies the follow-up inspection is conducted no later than 1 month after the first inspection.

2. **Professional inspection of compliance with this MG by individual RVAs** is conducted by the head of the Animal Welfare Division of the SVA CR, or an inspector designated by the SVA CR Department of Animal Health and Welfare Director, at least once every two years. In case of any detected deficiencies, the follow-up check of the RVA is conducted no later than 2 months after the first inspection.

## E 4. SUPERVISORY AND CONTROL ACTIVITIES

Inspections in the field of animal welfare were conducted at farms, in animal breeding establishments (i.e. breeding of companion animals, animals requiring special care) or at places of animal gathering and other activities with animals (slaughterhouses, animal gatherings, public performances, trade in companion animals, shelters and rescue stations for handicapped animals, zoological gardens, circuses and establishments conducting experiments on animals). Subject to inspections was also animal welfare during the national and international transport. Ritual slaughters were checked at slaughterhouses. In terms of methodology, the supervisory activities included also multiple partial inspections carried out simultaneously at a single establishment, namely when e.g. different types of breeding technology and different categories of animals had to be inspected.

The core of supervisory activities in 2010 were planned inspections. The number and the type of planned inspections are in line with the Multi-annual Plan of Inspections (hereinafter referred to as the "MPI") which lays down the minimum annual frequency of inspections or the minimum percentage of inspected entities of the total number of entities. The animal welfare inspections carried out at farm animal establishments were planned based on the centrally conducted risk analysis. The risk was assessed based on the criteria such as the number of

animals in the establishment, the species of farm animals kept, the date of the last inspection, the deficiencies detected during the inspections and the number of animals moved to a rendering plant and to slaughterhouses in the previous year.

The Plan of Inspections was modified in the course of the year. Over and above the planned inspections also unplanned inspections took place, ensuing from changes made in the course of the year, reported information, negative findings in other areas of animal breeding or conducted as follow-up checks of the fulfilment of corrective measures. There were also extraordinary inspections organised by the SVA and inspections monitored by other authorities than the SVA (MoA, SAIF).

In the framework of the presented system, throughout the monitored period the supervision of animal protection was executed by the Regional Veterinary Administration (RVA) inspectors. Evaluation of these activities is presented in tables, charts and maps with explanatory notes. In the monitored period a total of 207 500 inspections were carried out (see Supplements 17, 18, 19a, 19b). The presented maps (see Supplements 23 – 31) show the distribution of inspections and compare the situation in 1994 and 2010. In 2010, inspectors of the Regional Veterinary Administrations (RVA) conducted 12 841 inspections (in 2009: 14 688 inspections). Deficiencies were detected in 791 cases (in 2009: 880 cases) and involved 373 762 animals (in 2009: 78 181 animals). The number of proposals to initiate the administrative procedure (442) pursuant to the Animal Welfare Act submitted to municipal authorities of municipalities with extended powers (MEP) slightly increased as against 2009 when 426 proposals were submitted. It shall be born in mind, though, that also other sanctions were imposed. E.g. 83 on-the-spot fines were inflicted (see Supplement 1).

According to the data provided by the Ministry of Justice of the CR (see Supplement 13), a total of 681 persons have been prosecuted and 350 persons have been convicted for cruelty to animals since 1993. In the last 3 years, the numbers slightly grew, in 2008 a total of 26 persons were prosecuted, 21 persons were charged and 23 persons were convicted; 6 persons were heard in summary pre-trial proceedings. In 2010 a total of 19 persons were prosecuted, 15 persons were charged and 20 persons were convicted (after an appellate procedure was closed) for cruelty to animals; 15 persons were heard in summary pre-trial proceedings.

The number of inspections, administrative acts, including penalties, is presented in a breakdown by region and RVA territorial responsibility in Supplement 14. The penalties reflected the specific control findings detected during the supervisory activities of individual RVAs and were, as shown in the summary, addressed at various levels of administrative procedure. It shall be pointed out that during a single inspection the inspector can control multiple animal categories in different husbandry technologies and multiple kinds of activities involving animals. Potential legal actions, if initiated as a consequence of such inspections, are related to the inspection as a whole. It is impossible to link them explicitly to one single inspected animal category or one single inspected activity involving animals. When examining the presented tables, one should bear in mind that sums total in one table cannot be compared (for the reason of simultaneous violation of several provisions of the law in a single establishment) with those given in other tables, arrived at by different methodology. The differences in numbers are also caused for example by the prescribed evaluation methodology e.g. in case of tables for the EC etc.

When evaluating individual animal categories (individual activities involving animals), the results are automatically included in all the animal categories (activities involving animals) that were subject to the respective inspection. The charts included in Supplements 17 – 22 show the dynamics of development since the beginning of the monitored period, i.e. since 1993. An increase in both the number of deficiencies and penalties can be reported e.g. in case of targeted inspections. Based on the results of individual animal categories the highest percentage of recommended measures (in 2008: 12.4%; in 2009: 12.5%, in 2010: 11%) and law violations (in 2008: 8.9%; in 2009: 11.2%; in 2010: 10.2%) has always been reported in the category of companion animals.

The Supplement 7a, in accordance with the European Commission requirements, provides “Information on inspections of selected animal species and categories pursuant to Directive No 98/59/EC” expressed in percentage (see Supplement 7b). Similar data on inspections of other selected animal species and categories pursuant to Directive No 98/59/EC expressed in percentage is provided in Supplements 8a, 8b. Also Supplements 9a, 9b “Annual report on the protection of animals during transport” are drafted in line with the EC requirements.

The summary of deficiencies detected during inspections pursuant to the AWA, the Veterinary Act and Council Regulation (EC) No 1/2005 (see Supplements 10a, b; 11; 12) comprises the violations of individual provisions of the respective Act or Regulation. Codes given in the respective table correspond with the designation of sections, paragraphs and letters of the referred to Act or the articles, paragraphs and letters of the Regulation. This list has been expended to reflect the amendments to legislation. For the sake of clarity and to make the text shorter, the publication includes only the codes of sections that had been violated. Apart from deficiencies detected in animal protection and animal welfare, the inspections also detected 187 deficiencies in identification and registration of farm animals (Act No 154/2000 Coll.) that are crucial for the performance of inspection as such and that have been addressed in line with effective rules and regulations.

#### E 4.1. Supervision of the protection of farm animals

In 2010, the core supervisory activities consisted in planned inspections of farm animals related activities. The number and the type of scheduled inspections were determined in line with the Multi-annual Plan of Inspections. Animal welfare inspections in farm animal holdings were planned based on a centrally conducted risk analysis taking into account the number of holdings at the beginning of the year. The Plans of Inspections was updated throughout the year. The extent of conducted supervisory activities shall be judged in light of the data on population of farm animals in the CR as reported pursuant to the prescribed methodology by the Czech Statistical Office (CSO) as of 1 April of the given year. A different methodology for determining the number of animals in individual months is used by the Integrated Agricultural Register (IAR). It shall be noted that due to the application of different methodology these sets may sometimes show considerably different data. The most significant is the difference e.g. in the registered number of horses. Whereas the CSO methodology arrives at the number of 29 887 horses used for farming purposes, the IAR monitors the number of all registered horses and gives the number of 72 115 horses. In other animal species, according to the MoA the data does not differ significantly.

The analyses of inspections conducted in farm animal holdings (see Supplement 16) show that the largest share (92 %) in the number of inspected animals is represented by poultry. Nonetheless, poultry represented only 7 % of the number of conducted inspections. With regard to the size of establishments, on the contrary, a relatively large share of inspections (59 %) had to be carried out in cattle holdings, which however accounted for only 1 % of the number of inspected animals. Similar situation prevailed in inspections of pig, sheep and goat holdings. The presented charts illustrate the distribution of inspections over the period from 1993 to 2010. The maps on the other hand compare also the situation in 1994 and 2010. The number of inspections of monitored activities suggests that in recent years the number of inspections conducted in the group of farm and companion animals has been on a slight decline. Generally speaking, especially in case of care of farm animals the rise in the number of deficiencies and shortcomings detected in animal welfare reflects the lower demand for products of the given animal species (e.g. drop in farm gate prices of meat, milk, etc.). The long-term monitoring reveals that the increase in the number of deficiencies is generally reported in targeted inspections or when the new legislation takes effect. This stresses at the necessity to provide timely information to breeders.

In the supervision of farm animals related activities a total of 8 790 inspections (see Supplement 1) were conducted in 2010. These inspections involved 29 448 100 animals. The number of inspected animals depends on animal species and husbandry technology used. E.g. in 2007 the inspections involved 43 738 991 animals since more poultry and fish farms were inspected. In 2010 deficiencies were detected during 419 inspections (in 2009: 489) and involved 363 668 animals. A total of 170 proposals (in 2009: 144) to initiate the administrative procedure were submitted to municipal authorities of municipalities with extended powers (MEP), but also other forms of sanctions were applied, e.g. 83 on-the-spot fines were inflicted.

**Activities involving cattle.** In the course of 5 201 inspections (in 2009: 6 464) conducted in 2010 focusing on diverse use of cattle a total of 697 708 animals (in 2009: 353 284) of all categories were inspected. The given data does not include the data of daily welfare checks in consignments of animals at slaughterhouses and the same applies to all the other animal species mentioned below. Deficiencies were detected during 149 (in 2009: 155) inspections and involved 5 032 (in 2009: 2 541) heads of cattle (see Supplement 3). Repeatedly detected, namely in 20 cases, was the non-compliance with minimum standards, in 16 cases deficiencies were detected in feeding and watering and in 11 cases the prescribed aids failed to be provided. Moreover, the prescribed daily checks were not carried out and the detected shortcomings were not removed by the breeders. The inspections were made more difficult due to the detected concurrent deficiencies related e.g. to non-compliance with the requirements for registration and identification of animals.

In line with requirements laid down in Directive 98/58/EC, the inspection in cattle breeding establishments concentrated on various age categories of animals. Pursuant to EC methodology, of 9 121 calve holdings a total of 3 799 holdings were inspected and deficiencies were detected in only 56 of them (see Supplement 7a, b). In other cattle holdings a total of 4 778 inspections were carried out. Deficiencies were registered in 163 cases (see Supplement 8a, b).

**Activities involving pigs.** Diverse activities involving pigs were subject to 1 642 inspections (in 2009: 1 834) involving 628 237 (in 2009: 849 691) pigs (see Supplement 3). The IAR does not monitor the husbandry technology in order to facilitate the reporting of holdings with group pens and individual pens in individual categories of pigs (see Supplement 7a, 7b). The results of inspections for evaluation in accordance with Directive No 96/58/EC were therefore analysed only based on the information given in inspection protocols, with the group housing technology of pigs being inspected in 806 cases and the individual housing in 332 cases.

**Activities involving sheep and goats** were in 2010 inspected in farm animal breeding establishments and companion animal establishments during 1 663 inspections (in 2009: 868). The CSO registered an increase of 108 % in sheep breeding and 130% in goat breeding. Deficiencies were detected during 113 (in 2009: 111)

inspections and involved 1 906 sheep and goats, whereas in the course of 47 inspections of public performances (animal gatherings, exhibitions, etc.) 5 deficiencies were detected (see Supplement 4). In terms of percentage, during the inspections pursuant to EC methodology (see Supplement 8b), the highest share of non-compliances identified in sheep (15%) and goats (10.8%) concerned the identification of animals, registration and record keeping. The percentage, however, dropped as against the year 2009 with 35% non-compliances detected in sheep and 27% in goats. In case of companion animal establishments of both the animal species, deficiencies consisted repeatedly in keeping the animals in non-compliant premises and failure to notify their keeping.

**Activities involving horses.** A total of 800 inspections of activities involving horses were carried out (in 2009: 921). In 2010 the inspections involved altogether 18 820 horses (in 2009: 18 783). It shall be reiterated that due to different methodology the individual data sources report different numbers of registered horses. Pursuant to the CSO methodology there are 29 887 horses registered used for farming purposes, as mentioned above, whereas the IAR monitors the number of all registered horses and reports a total of 72 115 horses. The number of detected non-compliances in husbandry declined from 104 in 2008 to 52 in 2010 (see Supplement 5). There were 225 inspections involving 11 148 horses conducted during public performances. In 2010, only 1 positive finding was detected during 105 doping controls. Non-compliances in husbandry were identified on the occasion of 45 inspections involving 604 horses. Similarly to previous years, they were found particularly in companion animal establishments and consisted in malnutrition, use of unsuitable aids and improper care of horses.

**Activities involving poultry.** A total of 607 inspections (in 2009: 886) involving 19 207 518 birds (in 2009: 21 270 902) were carried out. Deficiencies were found in 17 cases and involved 338 228 birds (see Supplement 6). It shall be noted that also farms with less than 350 laying hens were subject to this set of inspections. In laying hens and broilers holdings, matters concerning husbandry and other activities involving poultry were linked to inspections for the implementation of Salmonellosis eradication programme. Similarly to previous years, particularly in summer season 12 inspections revealed difficulties with ensuring animal hygiene conditions (e.g. overheating of houses lacking adequate ventilation, microclimate defects, moist litter). Altogether 34 inspections were carried out at exhibitions and similar public performances (in 2009: 119) and deficiencies were detected only once and involved 39 birds on display.

In laying hens holdings, the evaluation pursuant to the methodology laid down in Council Directive No 98/58/EC (see Supplement 7a, 7b) was made for 2010. In the context of control of Salmonellosis eradication programme, repeated inspections were carried out in 7 holdings with free range conditions, namely 18 inspections, and deficiencies in the facilities and equipment of farms, watering and other husbandry practices were detected in 4 holdings. Inspections were carried out in 100 % of laying hen holdings with deep litter system, in 50 % of holdings with enriched cage systems and in 106 % of holdings with unenriched cage systems. The distribution of deficiencies is illustrated in the respective table.

In holdings with other categories of domestic fowl, a total of 172 inspections were conducted and deficiencies were detected in 11 cases (see Supplement 8a, b). For the sake of compliance with Council Directive 2007/43/EC, a total of 374 persons responsible for the care of chickens kept for meat production were trained before the effect of the amended Act, by which the requirement of sufficient training was met. Training courses were repeatedly held for all the RVA inspectors and there was a practical demonstration of the use of measuring technology and data processing.

**In goose holdings** altogether 31 inspections were carried out, including the repeated inspections, and deficiencies were detected in a single holding in case of which the inspector did not allow for bringing in new birds before the removal of deficiencies. During 60 inspections on **turkey farms** unauthorised interventions were repeatedly identified in one of the holdings. During 29 inspections carried out in **ratite holdings** deficiencies were detected in the size of housing facilities and husbandry practices (see Supplement 8a).

**Activities involving rabbits.** In 2010, a total of 13 inspections were performed in rabbit breeding establishments (29 515 rabbits were inspected) during which non-compliant conditions were identified in a single case only. Moreover, inspections were conducted in companion animal establishments, e.g. 35 inspections were conducted at exhibitions and other public performances and involved 6 096 rabbits. In 7 cases deficiencies were detected (failure to meet the requirements laid down in the rules, failure to apply for the approval by the municipality, animal escape). Deficiencies were identified in the sales of "pet-rabbits" (inadequate space allowances, failure to provide the buyers with information).

**Activities involving fur animals** – no deficiencies were detected during 7 inspections on red fox, mink, ferret and chinchilla farms (see Supplement 8a, 8b).

**Activities involving freshwater fish** intended for human consumption (see Supplement 5). The supervision of this category of fish included 371 inspections involving more than 7 million fish. The largest number of inspections (162) concerned the sales of and the trade in market fish. Of the total of 69 inspections of road transport, deficiencies were detected in two cases. It is essential that following the instructions provided to traders

in the last years, the number of deficiencies identified in pre-Christmas market sales of fish dropped to 4. In spite of that the activists organised critical protests during which "slaughtering of Christmas dogs" was simulated as a confrontation event.

#### ***E 4.1.1. Supervision of the protection of farm animals at slaughter***

The summary of the number of slaughtered animals in the CR in 2009 and 2010 based on the SVA CR data is presented in Supplement 15.

**Comprehensive inspections of slaughterhouses.** The animal welfare at slaughterhouses (inspection of equipment of slaughterhouses with respect to animal welfare, inspection of keeping the documentation, inspection of care of animals, inspection of potential accommodation of animals for slaughter, conditions for stunning, bleeding, etc.) in 2010, apart from regular daily checks of animal welfare at slaughterhouses, were subject to a total of 758 comprehensive inspections (see Supplement 2; the chart in Supplement 19). The minimum total number of planned inspections was adhered to and in majority of RVAs the number of inspections was even higher due to the need to address previous deficiencies, information, complaints, audit results, implementation of corrective measures and binding instructions. Altogether 12 comprehensive inspections led to the proposal to initiate the administrative procedure submitted to municipal authorities of MEP. Other measures applied are given in Supplement 2.

**Daily inspections of consignments at slaughterhouses** in terms of animal protection consist in the inspection of live animals preceded by inspection of documentation accompanying the consignment, documentation of the transporter, meeting the set transport requirements (duration of transport, distance, prescribed rest periods), status of the vehicle, handling the animals at slaughterhouses and slaughtering the animals as such as well as checks of its efficiency.

In **cattle for slaughter**, there were 106 360 inspections registered in the "Daily inspection of animal welfare at slaughterhouses by place of slaughter" file. Altogether 70 consignments of cattle for slaughter were identified as non-compliant. Of which in 6 cases the deaths occurred. In 10 cases non-compliant care of animals before slaughtering was detected and there was 1 case of reported of each inappropriate or insufficient stunning and bleeding. In 12 cases deficiencies were detected in the documentation of transporter, while in other cases non-compliant means of transport was used, etc.

In **pigs for slaughter**, of 70 226 consignments inspected a total of 395 consignments were non-compliant for the reason of injuries to animals and 256 consignments for the reason of the pigs being unfit for the journey (transport of inappropriate wage categories, chronic injuries, etc.). Deficiencies in unloading were detected during 10 inspections and there were 24 cases of non-compliant care of animals before slaughtering. Deficiencies in stunning were ascertained in 65 cases (wrong adjustment of the device, failure to provide periodical checks, etc.). It is positive that the number of deficiencies in accompanying documentation of transporters and the status and equipment of the means of transport dropped.

In **poultry for slaughter**, inspections were conducted in 7 848 consignments. Deficiencies were identified in 11 means of transport (non-compliance with capacity standards, failure to reduce the negative climatic conditions, etc.), in 4 cases the transporter's documentation was missing. In 25 consignments an increased number of deaths was reported. A few shortcomings were also found in unloading, including the presence of birds unfit for the journey.

**Horse slaughtering** continues to be monitored by the general public more closely than slaughtering of other animals. That is why preventive inspections were carried out at 2 facilities authorised to slaughter this animal species, beyond the time of slaughter, and once during the animal slaughtering. The following data illustrate that the slaughter of horses in the CR is only exceptional. In 2008 a total of 287 horses were slaughtered, in 2009 a total of 332 horses were slaughtered and in 2010 a total of 328 horses were slaughtered (see Supplement 15).

**Ritual slaughters.** Specific slaughterhouses were granted an authorisation by the MoA to perform ritual slaughters for the purposes of churches and religious societies in the CR, namely based on checks of approved slaughtering technologies. In 2010, a total of 21 authorisations were granted to 17 slaughterhouses (some slaughterhouses were authorised to perform both the kosher and halal slaughters). In 2010, a total of 5 comprehensive inspections of ritual slaughters were conducted, with no deficiencies found.

#### ***E 4.1.2. Supervision of the protection of animals during transport***

The conditions of animal transport (road and railway) in all animal species were inspected in accordance with Council Regulation (EC) No 1/2005 of 22 December 2004 on the protection of animals during transport and related operations and amending Directives 64/432/EEC and 93/119/EC and Regulation (EC) No 1255/97.

The Supplement 2 shows the number of deficiencies and imposed sanctions for all animal species transported by road, rail and air. The Supplement 9a, b gives an overview and percentage of deficiencies detected in the transport of farm animals by the EC methodology in line with requirements laid down in Council Regulation (EC) No 1/2005 on the protection of animals during transport and related operations. This set of inspections covers also the daily checks of consignments of animals at slaughterhouses and exported and imported animals.

**National transport of farm animals** was in 2010 checked in case of 336 consignments of animals transported within the territory of the CR, apart from transport to slaughterhouses (see Chart in Supplement 19). Apart from the health status of animals and equipment of the means of transport, subject to inspections were also the certificates of approval of the means of transport and professional competence of persons involved in animal transport (attendants). Altogether 9 administrative procedures were held and 9 proposals to initiate the administrative procedure were submitted to municipal authorities of municipalities with extended powers.

**International transport of farm animals** was inspected in a similar manner. A total of 1 333 inspections were conducted. Apart from the animals and the equipment of the means of transport, the inspections focused on the registration, Type 2 certificates of approval of vehicles and professional competence of persons involved in animal transport. In 2 cases a proposal to initiate the administrative procedure was submitted to the municipal authority of the municipality with extended powers. In 4 cases the competent authority of EC Member States were notified of deficiencies in animal transport. In 3 cases the RVA inspectors took part in the investigation of traffic accidents of road vehicles transporting animals, where euthanasia of some suffering animals had to be performed on-the-spot and other animals had to be transported to slaughterhouses.

**Transport of other animals** (apart from farm animals) was checked during 270 inspections focusing also on animal welfare conditions, equipment of the means of transport, registration in vehicles and professional competence of persons involved in animal transport. Upon initiative of the French authorities, an inspection of the transport of registered consignments of dogs and cats from specific suppliers was conducted and the authorities were notified that no deficiencies were detected in transporters of these companion animals. The illegal trade in these animals remains to be an outstanding issue.

Particularly during inspections of transit transport and approval procedure difficulties arose in the checks of compliance with and implementation of provisions of Council Regulation (EC) No 1/2005 caused by unclear technical requirements. At 6 training centres 21 additional training courses leading to the acquisition of the certificate of competence for drivers and attendants were held and a total of 359 persons were trained and granted the certificate in 2010.

#### ***E 4.1.3. Cooperation with the State Agricultural Intervention Fund (SAIF)***

In 2010 a total of 83 targeted inspections were conducted in holdings selected based on the SAIF risk analysis. No deficiencies were detected during all the 83 conducted inspections.

#### **E 4.2. Supervision of the protection of companion animals**

In 2010 the activities involving companion animals (see Supplement 1) were subject to 3 615 (in 2009: 3 905) inspections involving 2 223 549 (in 2009: 1 760 119) animals. It shall be noted in this context that activities involving companion animals very often involve large groups of animals such as aquarium fish, small rodents and bird species kept as companion animals, which has a notable impact on the number of inspected animals. Deficiencies concerning 6 365 (in 2009: 51 639) animals were ascertained during 398 (in 2009: 489) inspections. A total of 51 on-the-spot fines were inflicted and 116 penalties were imposed in the administrative procedure. This group of animals, despite the differences in the number of inspected animals of individual animal species, ever since 1993 has reported the highest percentage of imposed recommended measures (in 2008: 12.4%; in 2009: 12.5%, in 2010: 11%) and law violations (in 2008: 8.9%; in 2009: 11.2%; in 2010: 10.2%). Inspections of **activities involving dogs** are included in Supplement 5. A few dog breeding establishments with considerable number of dogs kept under non-compliant conditions were identified. Supervision of activities involving **domestic cats** resulted in 90 inspections carried out in cat breeding establishments, mostly upon initiatives of citizens, and deficiencies were detected in 9 cases. It is important to say that through the introduction of the rules of protection of animals at public performances these activities have improved and e.g. during 18 inspections involving 3 803 domestic cats no deficiencies were found. Similar situation prevailed in case of inspections of other public performances involving companion animals, e.g. 22 inspections focused on the exhibitions of 23 141 **aquarium fish** did not detect any deficiencies at all.

**Establishments breeding the animals requiring special care** were subject to 419 inspections involving 4 398 animals. Deficiencies detected during 11 inspections were addressed through 10 proposals to initiate the

administrative procedure submitted to the municipal authorities of MEP which involved 26 animals. E.g. 17 inspections were performed in companion animal establishments breeding bears, during which 30 animals were checked (1 proposal to initiate the administrative procedure involving 2 bears was submitted to the municipal authority of the MEP). Big cat (lions, tigers, leopards, ocelots, etc.) breeding establishments were checked during 28 inspections (1 proposal to initiate the administrative procedure submitted to the municipal authority of the MEP). Of positive impact was the change introduced by Decree No 411/2008 Coll., defining animal species requiring special care which reduced the number of animal species defined as terrarium animals. In relation to this new piece of legislation, however, the community of breeders and RVA inspectors repeatedly point at a troublesome way of identification of reptiles of a certain age and size and recommend to amend the Decree accordingly.

**In companion animal shelters** (see Supplement 2) a total of 117 inspections (in 2009: 176 inspections) were performed which involved 4 233 (in 2009: 6 691) animals. While in 2009 deficiencies were detected during 4 inspections and involved 55 animals, in 2010 they were detected during 3 inspections and involved 205 animals. In 4 cases a proposal to initiate the administrative procedure was submitted to the authority of the MEP. A recurrent shortcoming is improper registration of animals and failure to report a finding of a companion animal. In 2010 several cases heavily covered by media occurred in establishments which claim to be shelters, but do not comply with the set conditions and do not possess the respective authorisation and consequently cause the animals to suffer. With the view to provide qualified persons for capture of animals in line with requirements of the Veterinary Act, vocational training in the form of courses on capture of stray and abandoned animals and their handling was held, the content of which is stipulated by Decree No 296/2003 Coll., on animal health and its protection, on movements and transport of animals and on authorisation and professional competence to perform certain professional veterinary activities. The courses take place every year at the UVPS in Brno, namely ever since 1995.

**Trade in companion animals** was checked during a total of 713 inspections. Apart from planned inspections of pet shops, also unplanned inspections were conducted on the occasion of opening of new shops, upon initiatives and based on complaints concerning non-compliant conditions for traded animals, and follow-up checks.

Papers and results of research were presented at the 17<sup>th</sup> traditional conference Protection of Animals and Welfare 2010 at the UVPS in Brno, at the 25<sup>th</sup> technical seminar Topical Issues of Bioclimatology of Animals and at the 3<sup>rd</sup> seminar of the Society for Animals of the Czech Union for Nature Conservation intended for members of interest groups taking interest in animal protection matters.

Traditionally, the Foundation for the Protection of Animals evaluated the grant procedure for 2010 and announced grants for 2011 concerning the improvement of conditions of companion animals and stray animals population control. Successful was also another campaign organised by this Foundation and called "Fill the bowls" providing feed to animal shelters for animals in need.

#### **E 4.3. Supervision related to the care of wild animals**

The supervision of activities involving wild animals consisted in a total of 313 (in 2009: 258) inspections involving 56 143 (in 2009: 57 911) animals and deficiencies were detected during 26 (in 2009: 13) inspections involving 1 729 animals. Altogether 19 (in 2009: 9) proposals to initiate the administrative procedure were submitted to the municipal authorities of MEP (see Supplement 1).

In connection with movements of animals to other establishments, inspection of veterinary measures and licensing procedure of the Commission for Zoological Gardens (Commission for ZOOs) of the Ministry of Environment and inspection in relation to the final building approval of pavilions and inspection during the building permit procedure, a total of 83 (in 2009: 58) inspections were conducted in **zoological gardens** (see Supplement 1). A shortcoming was found in one zoo concerning improper animal handling and an escape of an animal. In 7 licensed zoological gardens periodical checks were conducted by the Commission for ZOOs. In all the cases the Commission concluded that conditions as laid down in the relevant legislation were complied with.

**In circuses** and similar establishments (see Supplement 1) a total of 122 (in 2009: 55) inspections involving 3 124 (in 2009: 1 335) animals were conducted and in 17 cases (in 2009: 6 cases) deficiencies were detected, which was why 14 proposals to initiate the administrative procedure were submitted to the municipal authority of MEP. Mostly it concerned the failure to notify the holding of a performance or non-compliance with the set conditions. Certain problems also consisted in the failure to observe the deadlines for approval of the rules of protection of animals at a public performance, involving also circuses and persons from abroad.

Upon initiatives of citizens, and sometimes in cooperation with the Czech Environmental Inspectorate (CEI), a total of 108 inspections were carried out in **zoo corners and similar facilities** in 2010. During 7 inspections



deficiencies were detected, 1 on-the-spot fine was inflicted and 4 (in 2009: 6) cases were addressed by the municipal authorities of MEP. Also a few cases of poaching and wild animal intoxication, often involving a group of protected birds of prey, were investigated.

**The rescue stations for handicapped animals** were checked during 17 inspections and additional checks were done pursuant to the Ministry of Environment (MoE) requirements prior to the approval procedure. The inspections involved 746 animals. In 1 case a proposal to initiate the administrative procedure was submitted to the municipal authority of the MEP. Decree No 114/2010 Coll., on the protection of handicapped animals in breeding took effect, specifying the requirements for the breeding of handicapped animals, equipment and the minimum space requirements for handicapped animals. In line with this regulation a training course was held and 26 persons passed the examination and were granted a certificate of professional competence of persons responsible for the care of handicapped animals.

#### **E 4.4. Supervision of breeding and use of experimental animals**

The Supplement 32, in line with the set EC methodology, gives an overview of the number of experimental animals used in the CR since 1994. The overview indicates that in 2010 a total of 366 007 animals were used for experiments and that the number dropped again as against the year before. Altogether 69 777 laboratory mice, 35 485 laboratory rats, 6 538 rabbits, 3 259 guinea pigs etc. were used in experiments; 149 200 birds were banded. Data broken down by individual type of experiments pursuant to the stipulated EC methodology is presented in Supplements 31 - 37.

The laboratory animal breeding establishments (see Supplement 1) were subject to a total of 123 inspections, during which no deficiencies were detected. In 2009, 137 inspections were conducted and two penalties were imposed in the course of administrative procedure. In connection with the administrative procedure concerning the accreditation of persons operating user establishments and granting certificates to persons operating breeding and supplying establishments, inspections were conducted always also prior to the accreditation procedure or certificate granting procedure.

In the framework of supervision of experiments on animals (see Supplement 2) a total of 117 inspections were carried out (in 2009: 132 inspections) involving 44 040 (in 2009: 77 694) animals. The ascertained shortcomings, just as in 2009, resulted in two proposals to initiate the administrative procedure submitted to the municipal authority of the MEP. In 2010, discussions were also held on the possibility of providing education using animals without the decision on granting accreditation at the secondary schools in Boskovice and Třebíč.

Training courses to acquire qualification to manage and conduct experiments on animals (Section 17 para 1 of the Animal Welfare Act) continued to be held at the UVPS and the CULS and in 5 courses additional 212 experts with university degree in sciences acquired the respective qualification.

### **E 5. ACTIVITIES PERFORMED BY THE ANIMAL WELFARE UNIT OF THE ANIMAL COMMODITIES DEPARTMENT OF THE MINISTRY OF AGRICULTURE**

Within the Ministry of Agriculture the animal protection falls under the responsibility of:

- Animal Commodities Department, Animal Welfare Unit (MoA-AWU) as the animal protection authority,
- Central Commission for Animal Welfare (CCAW) as a professional advisory body to the Minister of Agriculture.

In 2010, the MoA AWU was composed of:

- MVDr. Jiří Kruml, Head of the Unit,
- Ing. Kristýna Kruntorádová, officer – animal protection rules (until November),
- Ing. Jana Říhová, officer – animal protection rules (from October),
- Ing. Jiří Novák, officer – IT expert,
- JUDr. Jana Traplová, officer - lawyer.

#### ***Activities performed by the MoA-AWU:***

1. Routine daily activities.
2. Information outputs (both public and private):

- record keeping and processing of the number of animals used for experimental purposes in the CR in 2009,
- management of the animal protection website (MoA-AWU as well as CCAW), kept particularly in order to facilitate orientation and simplify the process for applicants in administrative procedure as well as to enhance public awareness on animal protection,
- keeping and regular updates of the list of entities involved in animal protection (shelters registered by the Regional Veterinary Administrations in particular),
- keeping a list of graduates from the course pursuant to section 17 para 1 of Act No 246/1992 Coll., on the protection of animals against cruelty, as amended (professional competence to manage, conduct and control experiments on animals),
- keeping a list of graduates from the course pursuant to section 26 of Act No 246/1992 Coll., on the protection of animals against cruelty, as amended (professional competence to conduct supervision in the field of protection of animals against cruelty),
- keeping a list of graduates from the course pursuant to Article 17 of Council Regulation No 1/2005/EC 2005 on the protection of animals during transport and related operations and amending Directives 64/432/EEC and 93/119/EC and Regulation (EC) No 1255/97 (competence for drivers and attendants of road vehicles),
- keeping a list of discussed, approved and not approved rules of animal protection at a public performance; regular provision of the approved rules to the State Veterinary Administration of the CR for the purposes of inspections,
- keeping a directory of decisions on granting accreditation to persons operating user establishments and of decisions on issuing certificate to persons operating breeding and supplying establishments,
- keeping a directory of persons operating user establishments who have applied for accreditation to conduct experiments on animals and of persons operating breeding and supplying establishments who have applied for the issuance of certificate.

3. Drafting new decrees to Act No 246/1992 Coll., on the protection of animals against cruelty, as amended:

- Decree No 114/2010 Coll., on the protection of handicapped animals in breeding (effective from 7 May 2010, the space requirements and equipment of spaces for selected species of handicapped animals are laid down by Annex No 1 to the Decree that will take effect on 1 April 2013),
- Decree No 128/2010 Coll., on competence for identification of dogs by tattooing (effective from 21 May 2010).

4. Drafting the amendment to Act No 246/1992 Coll., on the protection of animals against cruelty, as amended. The reason for the amendment is the necessity to incorporate Council Regulation (ES) No 1099/2009 of 24 September 2009 on the protection of animals at the time of killing and to transpose Directive of the European Parliament and of the Council 2010/63/EU of 22 September 2010 on the protection of animals used for scientific purposes.

5. Conduct of administrative procedures on approval of the rules of animal protection at a public performance pursuant to Decree No 5/2009 Coll., on the protection of animals at a public performance and in breeding – in 2010 a total of 121 administrative procedures were closed upon a final judgment (115 rules were approved, 0 rules were not approved, 6 administrative procedures were discontinued).

6. Conduct of administrative procedures on granting accreditations to persons operating user establishments and on issuing certificates to persons operating breeding and supplying establishments in line with Act No 246/1992 Coll., on the protection of animals against cruelty, as amended, and in line with Decree No 207/2004 Coll., on the protection, breeding and use of experimental animals, as amended, and cooperation with evaluators in this field – in 2010 a total of 24 administrative procedures were closed upon a final judgment, in all the cases the accreditation or certificates were granted.

7. Preparation of CCAW and CCAW Council meetings - 6 meetings of CCAW and 6 meetings of CCAW Council were held. Material and technical preparation of meetings, elaboration of certain documents for these meetings, taking minutes thereof, cooperation in the fulfilment of CCAW tasks.

8. Cooperation with the State Veterinary Administration of the CR on the compilation of the “Animal Protection Programme 2009” publication.

9. Provision of information, consultancies and technical advice for state administration bodies, non-governmental organisations and citizens.

10. Ongoing synergy with the State Veterinary Administration of the CR, the State Agricultural Intervention Fund, the Ministry of Environment, the Ministry of Industry and Trade, the Ministry of Transport and other state administration bodies and self-government bodies.

11. Elaboration of expert opinions, analyses, standpoints, judgments, methodological guidelines and expertise concerning the protection of animals against cruelty. Elaboration of legal interpretations of Act No 246/1992 Coll., on the protection of animals against cruelty. In 2010 the following legal opinions were published on the website of the Animal Welfare Unit:

- Opinion concerning the imposition of a sanction for the escape of a companion animal and failure to keep a dog on a leash following the amendment to Act on the protection of animals by Act No 291/2009 Coll.,
- Opinion on legal provisions laying down the obligations for the transport of animals which does not take place in connection with an economic activity and for the transport of farm animals for a distance of less than 50 km from the holding or within the holding,
- Methodology of MoA procedure for payment and reimbursement of costs incurred by the competent municipal authority or city district authority in relation to the provision of care of animals pursuant to Section 25 para 6 of Act No 246/1992 Coll., on the protection of animals against cruelty, as amended by Act No 312/2008 Coll.,
- Information on procedures ensuring care of animals pursuant to Section 25 para 6 of Act No 246/1992 Coll., on the protection of animals against cruelty, as amended by Act No 312/2008 Coll.,
- Interpretation concerning the expert opinion of the veterinary administration authority pursuant to Section 24a para 5 of Act No 246/1992 Coll., on the protection of animals against cruelty, as amended,
- Opinion on matters concerning the establishment of shelters and the temporary care homes,
- Opinion on matters concerning the identification of dogs by microchipping in line with the generally binding regulation of the municipality and concerning the effects of microchipping on health status of the dog,
- Opinion on the case of an attack, injury or killing of an animal by another animal or a man and on the case of an attack, injury or killing of a man by an animal.

12. Participation in comment procedures to the proposals for acts, decrees and other legislation submitted by other entities, which relate in any way whatsoever to animal protection.

13. Activities related to the issuance of certificates of professional competence to manage, conduct and control experiments on animals - in 2010 a total of 212 certificates were issued.

14. Participation in the organisation of courses for staff in charge of the performance of supervision in the field of protection of animals against cruelty pursuant to Section 26 of Act No 246/1992 Coll., on the protection of animals against cruelty, as amended. Activities associated with the issuance of certificates for the performance of supervision in the field of protection of animals against cruelty - in 2010 a total of 84 certificates were issued.

15. Participation in the organisation of courses for animal transporters in line with Article 17 of Council Regulation (EC) No 1/2005, on the protection of animals during transport and related operations and amending Directives 64/432/EEC and 93/119/EC and Regulation (EC) No 1255/97. Activities related to the issuance of certificated of competence for drivers and attendants - in 2010 a total of 359 certificates and the same number of IDs were issued.

16. Participation in the organisation of courses for acquiring the competence of a person responsible for the care of handicapped animals pursuant to Section 14b para 3 of Act No 246/1992 Coll., on the protection of animals against cruelty, as amended. Activities related to the issuance of certificates of professional competence of a person responsible for the care of handicapped animals - in 2010 altogether 26 certificates were issued.

17. Participation in the organisation of courses for acquiring the competence to take care of chickens kept for meat production pursuant to Section 12d para 7 of Act No 246/1992 Coll., on the protection of animals against cruelty, as amended. Activities related to the issuance of certificates of professional competence to take care of chickens kept for meat production - in 2010 altogether 375 certificates were issued.

18. Provision of translations and external materials, also for CCAW activities.

19. Publishing and lecturing – particularly the lectures by JUDr. Traplová on the topic of animal protection given at a few seminars held for the staff of public administration and self-government bodies, for the Bureau of Criminal Service and Investigation Police and at a seminar of the Society for Animals intended for a animal protection organisation staff, and at a seminar for cattle breeders. JUDr. Traplová also elaborated papers for the conference called “Urban and Municipal Management – Legal Aspects in Relation to Companion, Domestic and

Wild Animals 2010“ (Protection of chickens kept for meat production, protection of handicapped animals and provisions on dog tattooing in the new Czech decrees) and for the conference “Protection of Animals and Welfare 2010“ held at the University of Veterinary and Pharmaceutical Sciences in Brno (New decrees in the field of protection of animals against cruelty in 2010 and anticipated amendments to legislation).

Cooperation in the organisation of traditional international conferences: with the Faculty of Veterinary Hygiene and Ecology of the UVPS in Brno “Protection of Animals and Welfare 2010“ (Brno, September, 17<sup>th</sup> year), with the Czech Society of Bioclimatology “Topical Issues of Bioclimatology of Animals 2010“ (Brno, December, 25<sup>th</sup> year). Unfortunately, the financial support traditionally provided by the MoA for both the events was not granted. Moreover, the MoA-AWU co-organised the international conference “Urban and Municipal Management – Legal Aspects in Relation to Companion, Domestic and Wild Animals 2010“ annually held in Slovakia.

22. Other activities:

- in cooperation with the State Veterinary Administration of the CR, monitoring of press and distribution of daily and weekly overviews to CCAW members and MoA-AWU employees,
- archiving technical documents,
- monitoring technical literature.

## **E 6. ACTIVITIES OF THE CENTRAL COMMISSION FOR ANIMAL WELFARE**

In accordance with the amendment to Act on the protection of animals against cruelty promulgated under No 312/2008 Coll., in 2009 the CCAW became a professional advisory body to the Minister of Agriculture in the field of animal protection and started to work in a new make-up. The Minister of Agriculture issued a new statute and the rules of organisation of the CCAW, as of 29 January 2009 appointed a new CCAW chairperson and later also other CCAW members, the chairpersons of the committees were elected and the members were assigned to individual committees. Once the amendment to the Animal Welfare Act took effect, the CCAW ceased to issue decisions as an autonomous administrative authority. The agenda of administrative procedure pursuant to Section 20 of AWA was transferred within the Animal Commodities Department to the newly set up Animal Welfare Unit of the Ministry of Agriculture.

In accordance with its Statute, the CCAW gives opinions on matters concerning the protection of animals against cruelty upon its own initiative, upon the initiative of the Minister of Agriculture, upon the initiative of the relevant MoA unit, or upon the initiative of other entities. The committees accomplish the tasks in individual areas of animal protection within their responsibility, develop materials and supporting documents for meetings of CCAW, CCAW Council and relevant MoA units. In line with its Rules of Procedure, the CCAW issues opinions, calls, resolutions concerning the discussed items on the agenda of the meetings and provides opinions in the administrative procedure concerning the approval or non-approval of the rules of protection of animals in breeding, the rules of protection of animals at a public performance, and when adopting a decision on the withdrawal of an approval based on a request or by virtue of office, and on granting, modifying, suspending or withdrawing a certificate of a person operating a breeding or a supplying establishment or accreditation of a person operating a user establishment. The CCAW bodies are the CCAW Chairperson and CCAW Council composed of the CCAW Chairperson and Chairpersons of the individual committees.

At meetings of individual committees, on the occasion of 6 Council meetings and 6 plenary meetings, the CCAW was involved in drafting new proposals for decrees and submitted comments:

- on Decree on the protection of animals intended as companion animals in pet shops and other points of sale, the proposal is under preparation – on Decree No 114/2010 Coll., on the protection of handicapped animals in breeding,
- on Decree No 128/2010 Coll., on competence for identification of dogs by tattooing.

Moreover, the CCAW dealt with the current issues in the field of protection of animals and animal welfare, such as: matters concerning the protection of horses intended for work in the forest; elaboration of an opinion on the application for evaluation of "Preventa" equipment (udder hair remover for dairy cows); welfare related matters in pigs (e.g. concerning a suitable method of castration of boars, tail docking); comments to the rules of

protection of animals at public performances of companion animals (coursing, dogtrekking, agility etc.); protection and care of welfare of racing pigeons (e.g. differentiation between racing pigeons and feral pigeons; potential help to racing pigeons in need); it expressed opinion on the suitability of debeaking in artificially reared pheasants; it discussed the existence and care of non-indigenous invasive animal species in rescue stations and took part in the revision of the "CCAW Recommendations – Help to animals from our nature in need", the 2<sup>nd</sup> updated edition of which was subsequently published by the MoA; discussed were the conditions of protection of experimental animals and potential use of alternative methods in the framework of instruction, research and evaluation of safety of consumer products; the members of the Committee for the Protection of Experimental Animals attended the national conference of the Society for Laboratory Animal Science and the conference held by the EC (EPAA) on alternative methods.

As to the international events, the Chairperson of the Committee for the Protection of Farm Animals represented the CCAW at the 1<sup>st</sup> International Conference on Animal Welfare Education held by the EC in Brussels in October 2010. The motto of the conference was "Everyone is responsible" and it aimed at sharing more information on education and training instruments and programmes in the field of animal welfare and at enhancing awareness of the importance of educating citizens, farmers, animal attendants, transporters and other persons responsible for animal protection. The conclusions of the conference were presented to CCAW members, the report was forwarded to the MoA.

## E 7. CONCLUSIONS

The publication presents results of coordination activities performed by the MoA and other competent state authorities as well as results of supervisory activities conducted by the State Veterinary Administration inspectors in 2010. Through selected parameters in charts and maps, it monitors the progress in activities achieved in the period from 1993 to 2010. It provides information on the implementation of the AWA, including the activities of the Animal Welfare Unit within the Animal Commodities Department of the MoA and CCAW activities, it gives a list of legislation in force and the methodology governing the supervisory activities. The publication compiles and publishes summaries required by the EC, namely concerning the evaluation of conditions for activities involving farm animals and pursuant to the prescribed methodology also concerning the evaluation of the use of animals in experiments. The individual chapters in a consistent way describe the activities in relation to individual animal species and categories of farm, companion, wild and experimental animals.

The presented results suggest that the situation in various fields and in monitored activities involving animals has improved. Yet, from time to time, sporadic extreme cases of gross animal neglect resulting in animal suffering emerge and are covered by media. In 2010, the detected deficiencies involved a total of 370 thousand animals. That is why the shortcomings in individual fields are analysed, evaluated and pointed at with the view to identify a suitable solution and to prevent such situations in the future. A topical issue influencing not only the animal welfare but also the economics of breeding is the implementation of requirements laid down in EC Directive on chickens kept for meat production, amending the obligations imposed upon the keeping of laying hens in cage systems, changes in the requirements for the minimum standards in pig and fur animals rearing in 2012. Another amendment to the AWA and the changes in breeding conditions is essential once again, e.g. with respect to Council Regulation (EC) No 1099/2009 on the protection of animals at the time of killing and the new Directive 2010/63/EU of the European Parliament and of the Council on the protection of animals used for scientific purposes. Still missing and keenly awaited is the provision for technical conditions for the implementation of Council Regulation (EC) No 1/2005 on the protection of animals during transport and related operations.

The presented results suggest that the professional as well as social attention paid to the conditions of animal protection and animal welfare of farm animals, companion animals, wild animals and also of the protection of experimental animals bring about a number of problems which tend to pertain, in spite of partial successes, and they still have to be addressed. In the field of protection of companion animals, the stress was recently put particularly on public awareness and education activities. Newly addressed and incorporated in legislation were matters concerning the care of handicapped animals.

### **Measures to be taken based on the analysis of results:**

- In the field of animal protection and animal welfare, attention shall be paid to professional and organisational tasks ensuing from the membership of the CR in EC bodies concerning
- the "Universal Declaration on Animal Welfare",
- technical requirements complementing Council Regulation (EC) No 1/2005,

- proposals for the current problems of animal protection and animal welfare.
- The MoA, SVA CR and competent state authorities in cooperation with the CCAW as an advisory body to the Minister of Agriculture will in their activities build on the “Community Action Plan for the Protection and Welfare of Animals 2006-2010“. Additional comments and analytical findings will be submitted to the competent authorities with regard to the drafting of legislation at the Community level.
- When amending the legislation, requirements to reflect the EU legislation shall be met - compliance with the implementation of the amended Council Regulation (EC) No 882/2005 on official controls performed to ensure the verification of compliance with feed and food law and animal health and animal welfare rules, specific activities will focus on the adoption of legislation (decrees) in compliance with the provisions of the AWA.
- Animal protection authorities, particularly the MoA and SVA CR, shall together with the Ministry of Transport create conditions in order to meet the requirements set by the technical rules supplementing Council Regulation (EC) No 1/2005 of 22 December 2004 on the protection of animals during transport and related operations and amending Directives 64/432/EEC and 93/119/EC and Regulation (EC) No 1255/97.
- More legislation will be harmonised with the EC legislation, primarily with Council Regulation (EC) No 1099/2009 on the protection of animals at the time of killing and the new Directive 2010/63/EU of the European Parliament and of the Council on the protection of animals used for scientific purposes.
- The MoA and competent authorities shall create conditions for the implementation and evaluation of cross-compliance (CC). Based on the results of inspections conducted in animal welfare under the “Animal Protection Programme”, or bearing in mind the risks identified in other areas, or based on foreign experience selected risks shall be identified which are relevant for the welfare of animals in breeding and which shall be taken into account in the conduct of inspections. For 2011, activities involving inspections of individual cattle and pig categories are foreseen.
- MoA, SVA CR and competent authorities shall prepare conditions for successful cooperation and discussions with experts during the scheduled DG(SANCO) missions.
- The SVA CR in line with the amendment to the Veterinary Act and its implementing legislation shall ensure the compliance with the conditions of supervision of the protection of animals and animal welfare; inspections will be conducted pursuant to the new methodological guidelines and in accordance with the “Guidelines for the conduct of internal audit of the SVA CR official control systems“ comprising efficient procedures for the verification of effectiveness of official controls and follow-up measures.
- The SVA CR shall analyse and evaluate the “AP Programme“ at the meetings of RVA Chief inspectors. Information on the evaluation of activities in the field of farm animals breeding, inspections of transport and use of experimental animals, including this bulletin, will be forwarded to the EC. Newly addressed will be the methodology of the plan of activities in the field of protection of animals and care of their welfare.
- In 2011, the SVA shall ensure continuous updates and potential improvement of the established SVA IS welfare module.
- The MoA - Animal Welfare Unit, the SVA CR, RVA inspectors and CCAW members shall work in the given field in synergy with citizens, interest associations of citizens, breeders as well as state administration bodies with a view to continuously improve the situation in animal protection.
- Information and public awareness activities will be provided to both the citizens and breeders. Information on the protection of animals will be made available on the Internet:

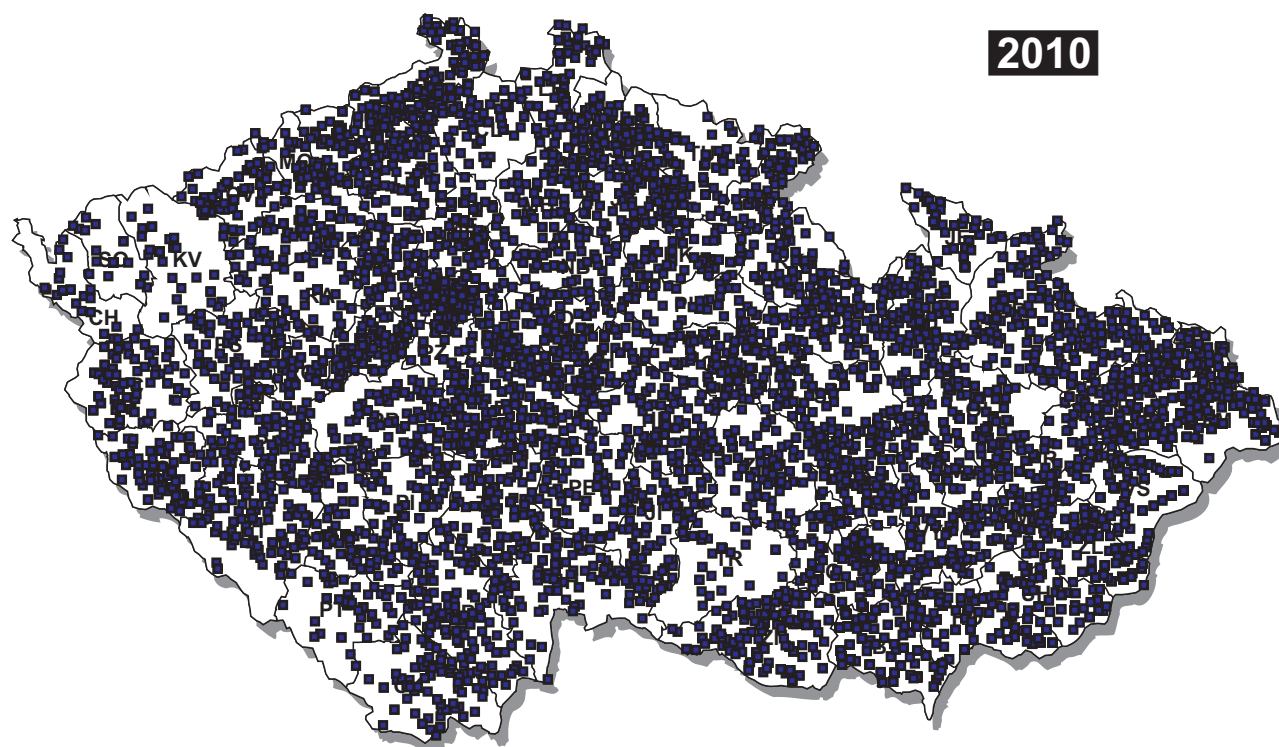
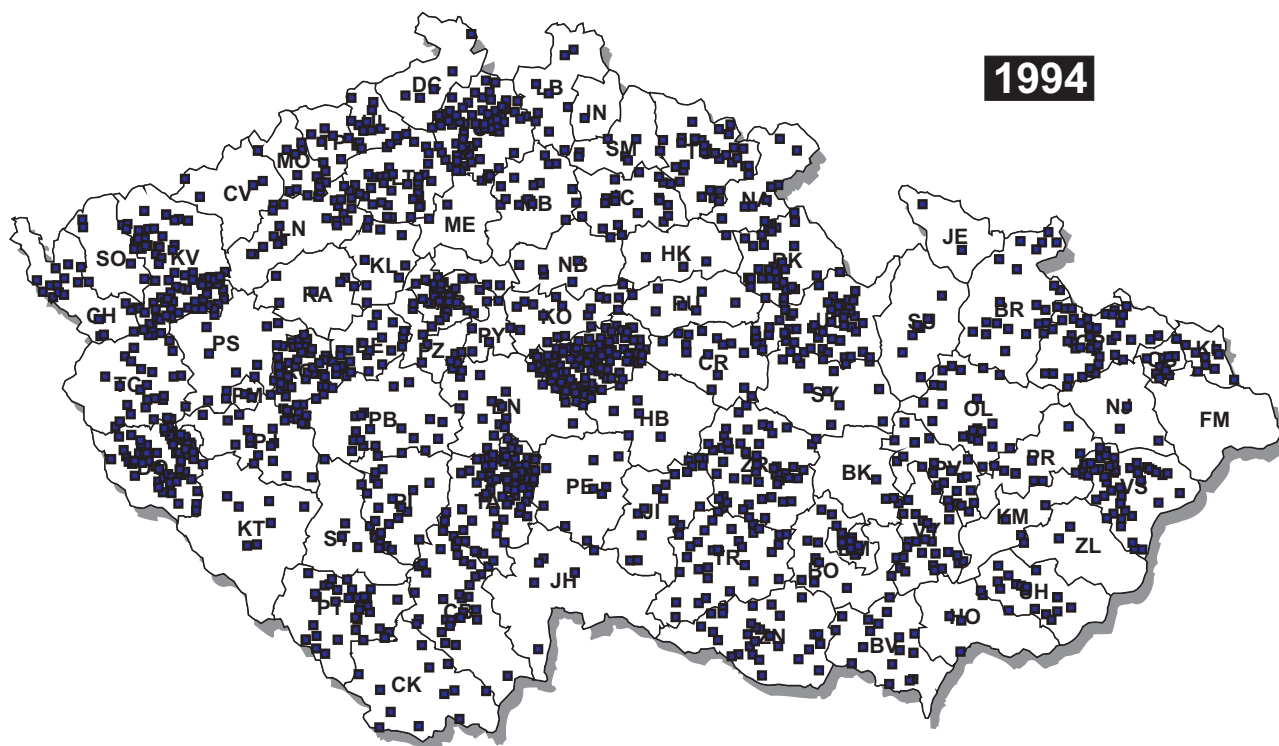
**Podíly porušení zákona č. 246/1992 Sb.

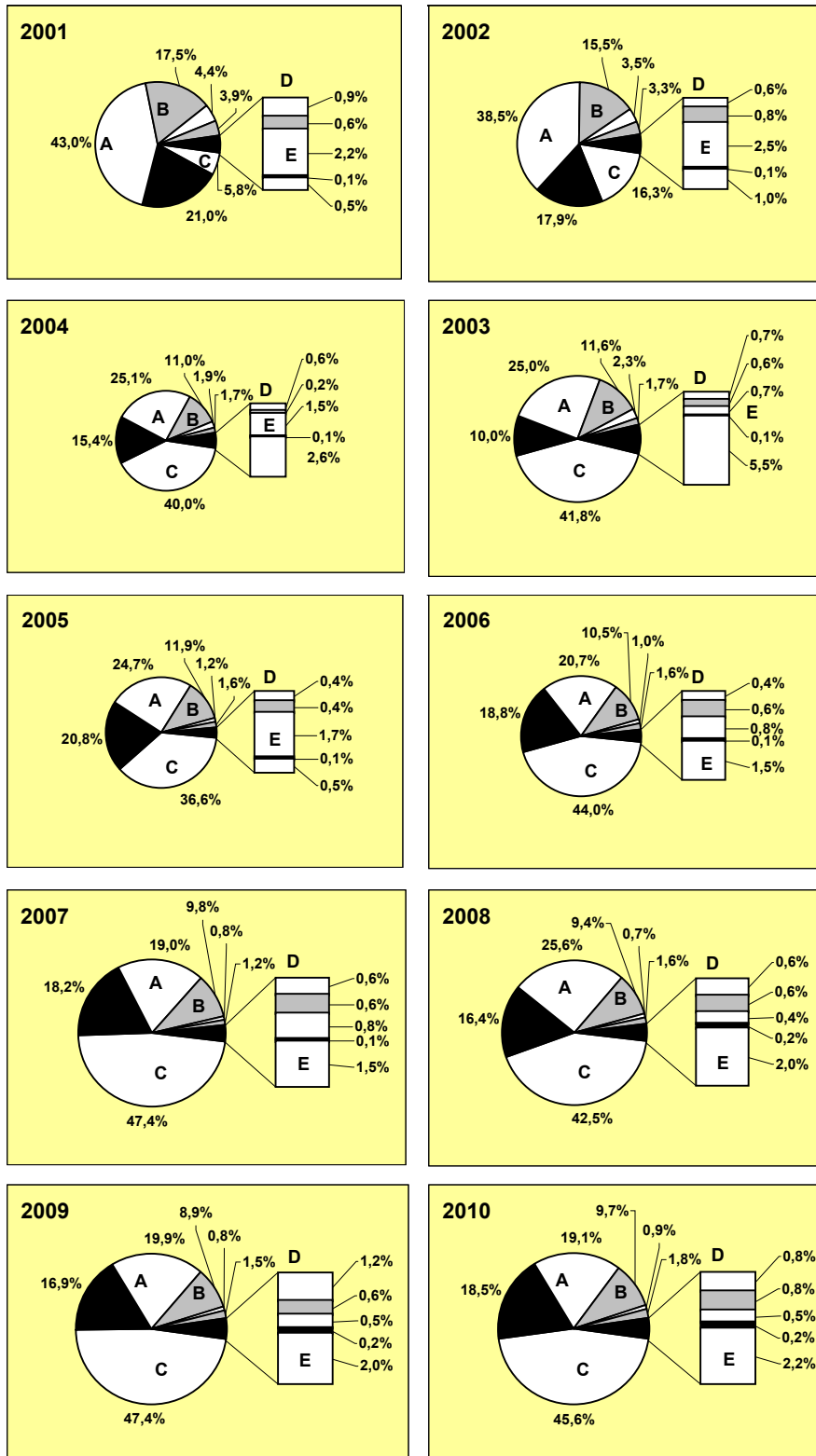
